

## Friends of East Rosebud Fun Run/Walk announced

The Friends of East Rosebud have submitted a special use application to the Beartooth R.D. Custer Gallatin National Forests for a new fun run/walk, 5K, 10K foot race. The race is proposed on July 27, 2014 and the course would utilize the East Rosebud Road from the parking lot (located near the mouth of E. Rosebud Lake) to Jimmy Joe Campground. Beginning in the morning, an estimated 60 racers plus spectators and race support personnel are anticipated for the event, which would conclude by early afternoon.

The Beartooth Ranger District plans to issue a temporary special use permit for the event. All activities will take place on the existing National Forest road system and race organizers would be responsible for the health and safety of the event and all pre and post operational preparations and clean-up of the event. The proposed event adheres to the Forest Plan (Management Area F) in helping to provide a spectrum of recreational opportunities and settings in and around developed recreation sites and corridors.

The Beartooth Ranger District is accepting public comments regarding the issuance of a temporary special-use permit for the proposed recreation event. All comments should be received at the Beartooth Ranger District Office no later than May 2, 2014. All substantive comments will be used in the development of an Environmental Analysis as required by the National Environmental Policy Act of 1969.
